Cease and Desist Order

Your organisation is branded Jehovah's Witnesses. Clearly you understand you are promoting yourselves a people that belong to Jehovah. You are owned by Satan. Jehovah and Satan have no share with one another. You may not use the name Jehovah. Both Jehovah's name and Divine identity are backed by My flesh. You have a duty and obligation to demonstrate Satan's wisdom, cleanliness, and zeal for knowledge in all you do abandoning all Ba'al pursuits.

Sirs:

This is a legal order to cease and desist your use of Jehovah in your organisation branding and name. You branded yourselves International Bible Students once: why not revert. That is all the courtesy this notice has to offer.
